

North Canyon Buhl Clinic

In order to better serve the communities surrounding our main location in Gooding, North Canyon opened a Rural Health Clinic (RHC) in Buhl in January 2019. To qualify as an RHC, the clinic must be located in a rural, medically underserved area and provide primary care services. The Buhl Clinic offers family medicine, pediatric care, immunizations, men's and women's health care, orthopedics, dermatology and general surgery. The response to North Canyon's presence in the Buhl community has been phenomenal, and we are extremely proud to provide them with the same high-quality, personalized medical care that we offer in our main facility.

North Canyon Orthopedics and Sports Medicine

Opened in June 2019 in Twin Falls, North Canyon Orthopedics and Sport Medicine Clinic provides comprehensive care for musculoskeletal injuries and diseases. With over twenty years of experience, our Board Certified orthopedic surgeons, Dr. Toby Anderton and Dr. Guy Grooms, provide a range of operative and non-operative medical solutions, including the first robotic-assisted joint replacement technology in the Magic Valley. Our innovative MAKO program allows for a personalized surgical plan that ensures accurate placement of implants and better outcomes for patients. North Canyon Orthopedics and Sports Medicine offers a wide-range of operative and non-operative orthopedic services including sports medicine, physical therapy, joint injections, and joint replacement.


Our surgical services department is staffed with highly skilled nurses, technicians and anesthesia personnel. With specialists in





Lab Procedures



As North Canyon Medical Center continues to expand service lines for our patients and provide additional healthcare options for residents of the Magic Valley, it should be no surprise that our quality is recognized regionally and nationally.

In 2019, North Canyon Medical Center was once again designated a Five-Star facility by the Centers for Medicare and Medicaid Services (CMS) marking this the third consecutive year we've received this honor. Of all hospitals across the nation, only 407 of 4,500 were awarded this prestigious five-star rating. Only six hospitals in Idaho received this accolade. CMS assigns star ratings based on a hospital's performance across seven areas of quality, including mortality, safety of care, readmission rates, patient experience, effectiveness of care, timeliness of care and efficient use of medical imaging. These seven measures are monitored internally and submitted monthly to CMS.

The measures we submit to CMS guide performance improvement initiatives in various departments of the hospital. In

November 2019, each area in the hospital created its own department scorecards which are discussed internally and measure four areas: customer satisfaction. human resources, quality and safety, and operations. This data informs each department director on what is working well within their department and serves as a guide for making efficient, cost-effective decisions with patient care always top of mind.

North Canyon Medical Center remains accredited and regulated through CMS and DNV-GL. This is North Canyon's third year of being a DNV-GL accredited facility. The DNV-GL 3-year accreditation is monitored through annual site visits. These annual surveys are tied to the specific CMS Conditions of Participation for Critical Access Hospitals and suggest areas where


improvements can be made. It is the duty of every employee to ensure that North Canyon maintains the high level of quality health care. This is a responsibility we don't take lightly. The DNV-GL accreditation adds another level of review of the care we provide our patients.

This year North Canyon also started the process of ISO 9001 certification through DNV-GL. ISO 9001 is a quality management system that focuses on process improvement and is applied to many industries, including healthcare. ISO principles help us deliver services in a more streamlined and cost-effective way.

North Canyon continued to participate in the inpatient satisfaction survey program (HCAHPS) with Press-Ganey. These surveys are sent to patients after they've been discharged from their inpatient stay. The scores are reviewed monthly by the quality and safety committee and the governing board to identify any potential trends so action can be initiated quickly. Below is a recent HCAHPS report.

North Canyon Medical Center strives to continuously improve the quality, safety and efficacy of healthcare for our patients. We prioritize quality improvement initiatives based on the impact they'll have for patients and their families. It's an exciting time for North Canyon as we continue to grow in the Magic Valley.

Since opening the new hospital in March of 2010, North Canyon Medical Center's revenue has more than doubled.

This growth is attributed to our ability to care for more and more patients by adding service lines and recruiting family practice providers and orthopedic and general surgery physicians, as well as adding clinics in both the Buhl and Twin Falls communities. In just one year, we've grown our revenue by 17 percent. One area in which we have seen significant growth is surgical services, which not only impacts the operating room, but also radiology, laboratory, medical supplies, and inpatient services. We are truly living our mission statement of growing a medical organization that serves our communities in the Magic Valley.

North Canyon spends almost \$32 million annually to provide care to our patients, a 9 percent increase over the prior year. Our largest expenditure is also North Canyon's most valuable asset—the people who work here! North Canyon is one of the largest employers in Gooding County, and we spend over \$17 million on salaries and benefits to our employees. The hospital not only has a significant economic impact on Gooding County, where 57 percent of our employee base resides, but also in Twin Falls County. where 22 percent of our employees live,

and Jerome County, where 11 percent of our employees live. North Canyon also spent \$9.8 million on professional and purchased services, supplies and other expenses. Of this \$9.8 million, 23 percent went to Idaho businesses. Investing back in our communities is important to our organization.


As a non-profit, North Canyon Medical Center provides benefits and services to the communities we serve. One direct benefit is the health care we provide for free, or for which the hospital is not fully compensated through charity care and medical indigent programs. For the fiscal year ending on September 30, 2019, North Canyon provided uncompensated health care services to those in need at an estimated total cost of over \$600,000. Additionally, the hospital provided services to those in need of specialized care that were subsidized by the hospital at an estimated total cost of more than \$320,000. North Canyon also provided community health improvement services available to the general public at an estimated cost of \$430,000. Providing these services is an important priority for North Canyon because they improve the health of the community.



Thanks to the generosity of our friends, fundraising for our new chapel is underway.
